What is it?

The minimum supply of natural gas is a financial contribution for natural gas, twice a month, during the winter period from November 1st to March 31st. This amount will be put on the budget meter card. After the winter, the OCMW can reclaim 30% of the contribution from you.

What should you do?

Go to the OCMW / Social House of your municipality and ask if you are eligible for the minimum supply of natural gas. Even if you are not a customer of the OCMW.

- If applicable the **contact details of your debt counselor**



What will happen next?

You have a meeting with the social worker of the OCMW. He will investigate whether or not you are eligible for the minimum delivery. If your application is approved, the amount will be put on your card (with a classic budget meter) or the amount will be put on the meter (with a digital meter with budget meter function).
